
The "Saraswati-Dhanwantari Medical, Educational, Social & cultural Foundation, Parbhani Dist. Parbhani has applied for establishment of a dental college at Parbhani. On careful consideration of the proposal, the Government of Maharashtra has decided to issue this Essentiality Certificate to the application for the establishment of a Dental College with 100 seats.

It is certified that :-

- The proposed Dental College has tied up for five years from beginning of the college with Government District Hospital, Parbhani which has provision for 100 beds and which is located within 10 Kilometres radius of the proposed Dental College, till they have their own Hospital in the same premises. It shall be the duty of the applicant to produce evidence that the infrastructural facilities such as teaching, pre-clinical, para-clinical and allied medical sciences are own by the proposed dental college itself.
- The applicant owns and manages a dental clinic with 10 chairs.
- It is desirable to establish a dental college in the public interest
- Minimum 30 Out Door Dental Patients per day are available to begin with.
- The credibility and the financial status of the applicant has been verified.

It is further certified that in case the applicant fails to create infrastructure for the Dental college as per Dental Council of India norms and fresh admissions are stopped by the Dental Council of India, the State Government shall take over the responsibility of the students already admitted in the college with the permission of the Central Government. This certificate is valid upto 31<sup>st</sup> December, 2008.
